REQUESTING THE COMMISSIONERS COURT
TO CLOSE ROAD TO THE PUBLIC

Pursuant to §§251.051, 251.052 and §251.058 of the Texas Transportation Code, the following parties, each being a property owner of land situated in Upton County, Texas, hereby Petition the Commissioners Court of Upton County, Texas, for the closure of a public road, having first provided twenty (20) days notice of their intent to apply by closure of the road in conformity with law. The proposed closure will not adversely affect the public interest, the road subject to closure having been abandoned and without maintenance for a period of time in excess of three years, and being enclosed within the property of those individuals seeking closure, and no other party requiring the road to access their own separate tracts of land.

The road, or portion thereof, to be closed, is described as follows:

The Road to be closed is known as Upton County Road 230, located approximately 7 miles East from State Highway 349 and South of FM1555, extending a distance of approximately 10 miles into the lands of 7R Ranch (Ratliff Ranch, Dustin and Mike Ratliff), Petitioner herein, and is described more fully as set forth herein:

Point of Beginning: GPS Coordinates-- 31° 20' 50" N 101° 49' 49" W
Point of Termination: GPS Coordinates-- 31° 14' 11" N 101° 51' 12" W
Distance: 10 miles

The parties signed below make application for the closure of said road by filing a petition with the Upton County Commissioners Court on the 6th day of April, 2020, at a regular meeting of said Court scheduled for that date. Persons requiring further information should contact the Upton County Judge, Hon. Dusty W. Kilgore, at the office of the county judge in the Upton County Courthouse, Rankin, Texas, or by calling at (432)693-2321. Interested parties should also plan to attend the Commissioners Court meeting on the date above.
