PLEASE BE ADVISED:

Pursuant to Section 18.009 of the Texas Election Code. UNLAWFUL USE OF MASTER FILE INFORMATION

- (a) A person commits an offense if the person uses information in connection with advertising or promoting commercial products or services that the person knows was obtained under Section 18.008.
- (b) An offense under this section is a Class A misdemeanor. Acts 1985, 69th Legislature, Ch. 211, §1, effective Jan.1, 1986. Amended by Acts 1997, 75th Legislature, Ch. 864 §13, effective Sept. 1, 1997.

NOTE: Punishment for offenses. The Penal Code classifies offenses as a Class A misdemeanor or a first, second or third degree felony or state jail felony (also capital felony) and prescribes the punishment for each classification as follows (Citations are to the Penal Code): CLASS A Misdemeanor; a fine not to exceed \$4,000; confinement in jail for a term not to exceed one year; or both such fine and confinement."
