Anticipated Improvements:


Greasewood Solar, LLC anticipates constructing a 270-megawatt utility scale single axis tracker photovoltaic facility designed to use solar power to generate electricity. The investment would include the following: solar modules/panels, metal mounting system with tracking capabilities, battery or battery system, underground conduit, communications cables and electric system wiring, combiner boxes, a project substation including breakers, a transformer and meters, overhead transmission lines, inverter boxes on concrete pads, an operations and maintenance facility, fencing for safety and security, telephone and internet communication system, meteorological equipment to measure solar irradiation and weather conditions, and any other eligible ancillary and necessary equipment for commercial operations of the proposed project.

Estimated Cost of the Improvements: The best estimate of capital investment of all such improvements subject to the requested tax abatement is \$324,000,000.
