

**ORDER EXTENDING VOTING HOURS**

It is ORDERED that the November 7, 2023, Upton County Constitutional Amendment Election shall proceed as required under state and federal law except that the polling locations shall remain open until 7:45 p.m.  
It is further ORDERED that this order shall be posted on Upton County's website and the Elections Administrator's website shall be updated to reflect the terms of this order.

It is further ORDERED that any vote cast after 7:00 p.m. by a voter who was not inside the polling place or waiting to enter the polling place by 7 :00 p.m. shall be cast as a provisional ballot pursuant to Texas election laws.

**EMERGENCY PETITION TO EXTEND VOTING HOURS**

1. I, Hayley Abalos, Upton County EA, requests emergency relief to extend voting hours.
2. Today, November 7, 2023 is a November Constitutional Amendment Election.
3. An active shooter in the area caused the closure of one polling location.
4. The territory for this election covers 3 precincts.
5. Pursuant to Texas election laws, ballots cast by individuals who arrive at a polling place after 7:00 p.m., but before the polls close, will be voted as provisional ballots.

6. Accordingly, the Upton County EA asks this Court to extend the hours at all polling locations from 7:00 p.m. to 7:45 p.m. to allow voters who may have been affected by today's emergency conditions additional time to vote. This will also give voters who arrive at a closed polling location close to 7:00 p.m. the opportunity to travel to an open location.


