THIS BUDGET WILL RAISE MORE REVENUE FROM PROPERTY TAXES THAN LAST YEAR'S BUDGET BY \$2,326,192.00 WHICH IS AN INCREASE OF 17% AND OF THAT AMOUNT \$319,362.00 IS TAX REVENUE TO BE RAISED FROM NEW PROPERTY ADDED TO THE TAX ROLL THIS YEAR. THE TAX RATE FOR M&O WILL EFFECTIVELY BE RAISED BY 5.48% AND WILL INCREASE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$17.00.
